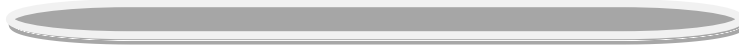

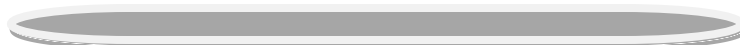

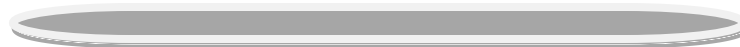




***NEW TRENDS AND TWISTS IN FRAUD***

**TOPIC OVERVIEW:** CAFC overview, mandate, fraud reporting trends, current scam trends and touch on their fraud prevention and disruption initiatives.

**Keith Ward** is an intelligence Researcher/Analyst with RCMP. He's been with the Canadian Anti-Fraud Centre since 2009 and joined the Operational Support Unit in 2015. Keith is currently involved in multiple aspects of the CAFC disruption program. Along with providing tactical support to law enforcement, Keith is currently assigned to Fraud Prevention and Education and is involved in social medial initiatives to bring awareness and resources to victims of fraud.

**TOPIC OVERVIEW:** A man, Daniel P. Reeve, who previously rode around in a stretch limo, wore the best suits and wrote seven financial advice books was reduced to a common criminal after being found guilty of ripping off 41 investors of \$10 million – awaiting sentencing.

- Insights from a current, complex investment fraud so that all attendees can relate to the need that the Crown and Police/Corporate Investigators have to be fully invested and working together
- Practical ways to encourage a strong strategic team including police, prosecutors, regulators and the private sector
- Innovative methods to investigate and prosecute/litigate offenders so that justice can be done
- Exposure to the preparation and presentation of a Crown/Civil Brief using full Electronic Disclosure

**Norm DeBoer** has been a member of the Waterloo Regional Police Service for the past 28 years and is currently in Rural Patrol. He was in the Major Fraud Branch for 14 years investigating major frauds. Prior to joining the Fraud Branch he was a Divisional Fraud Officer and a Tactical Officer on the Emergency Response Team.

He has a two year Law and Security diploma from Niagara College in 1990. He has taken a number of career oriented courses at the University of Waterloo, Wilfrid Laurier University and Conestoga College. He has completed numerous interviewing and interrogation courses. He has completed the Canadian Securities Course and the Financial Planning Course. He has received the designation of Certified Fraud Examiner and a Certified Forensic Investigator. He is currently involved in graduate studies.

He has extensive experience with property-casualty, criminal, life, health and disability insurance investigations across Canada and internationally. He has presented evidence and testified in precedent setting cases at the Supreme Court of Ontario and Financial Services Commission of Ontario.

In addition to overseeing the daily operations and company's development, Elliott is the primary point of contact for many clients. He is regularly asked to provide in-house training to various insurance company staff on the function and use of investigations, surveillance and social media surveillance for insurance purposes.

***GREG MCGUIRE – DETECTIVE***

***FORENSIC IDENTIFICATION UNIT***

**TOPIC OVERVIEW:** This presentation will cover the basics of Crime Scene photography including some fundamentals of “telling the story through photos”, as well as victim and evidence photography. The collection and handling of exhibits/evidence will also be discussed, including packaging and continuity considerations for seized items.

**Greg McGuire** has been a member of York Regional Police since 1988, and since 2013 holds the rank of Detective. He has worked Uniform Patrol in Vaughan and Richmond Hill / Thornhill as well as a secondments to the Criminal Investigation Bureau in Richmond Hill and Court Services in Newmarket. Greg has been using photography as part of his role in Policing since 1998 when he was first trained as a Scenes of Crime Officer (SOCO). Greg is currently assigned to the Forensic Identification unit, where he has worked continually since 2000.

Greg has been involved in teaching within the Police Community including teaching to Scenes of Crime Officers on various subjects, including crime scene photography and documentation and collection of evidence. He also attends scenes, where he uses this training, to document major crime scenes such as Homicides, and Robberies.
